A veterinary diagnosis must be submitted to the breeder in writing. Gunbil German Shepherds has the option to get a second opinion. The breeder is not responsible for contagious disease or accidental death.

Gunbil German Shepherds agrees to warranty hips and elbows at fair or better (A3) or un-certifiable hips/elbows. **A certified, orthopedic veterinarian** must provide written diagnosis and x-rays which clearly identify Dysplasia. It is recommended that all clients have x-rays taken and submit them to The Orthopedic Foundation for Animals (OFA), who will review the x-rays and determine a hip rating. Customers are welcome to submit preliminary findings; however, the guarantee applies only to dogs two years of age or older. X-rays of females must be submitted prior to pregnancy. If the buyer elects to do surgery on the hips and/or elbows (before age of two years), the health guarantee will be voided.

The paperwork to register our dogs can take 3 to 9 months to receive.
